2. If the Booking is made less than 8 weeks in advance of the holiday start date, payment of the Final Amount is required in full at the time of booking.
3. A mandatory Cautionary Deposit is due when paying the Balance and will be refunded within 1 month of the end of the holiday less the value of any damages incurred. This amount is in addition to the Total Rental Payment.
4. **Cliff Hollow is available from 5:00pm on the holiday start date until 10:00am on the holiday finish day. In the interests of future guests and the cleaners these times must be strictly adhered to.**
5. Electricity and water charges are included in the Rental Payment. Essential telephone call charges only are included in the Rental Payment. All bed linen, bath mats, bath and hand towels are included in the Rental Payment.
